- A maximum of 3 entries will be considered; however, artists need not feel compelled to submit the corresponding maximum number of images.
- Artists agree to permit use of submitted images for media/promotional purposes and to allow additional photography as may be required for media/promotional use with the understanding that proper credit will accompany any such images.

\_\_\_\_ Please attach a signed copy of the provided “Hold Harmless agreement.” Artists are solely responsible for insuring their own pieces. Although RHINO will take reasonable measures to ensure the safety and security of submitted pieces, it cannot accept responsibility for loss or damage.

\*\* Delivery of Artworks selected for exhibition: Artists are responsible for delivery of accepted pieces to the gallery between Sept 10, 2009 & Sept 20, 2009 (Gallery hours: Mon-Sat 10am-7pm & Sun 12-6). Artwork will remain on display through Nov 15, 2009. Artists will be responsible for shipping arrangements following the close of the exhibition. Payment to cover returns, reusable packing/shipping materials, and instructions are required. Works not removed from the gallery within 30 days may be disposed of as the gallery chooses.
